Thank you for booking your Christmas party at The Georgian Townhouse, we hope you'll have a great time with us! We want your festive celebration to go as smoothly as possible, so we've set out some ground rules, which we ask you to read. When you've read these terms and conditions, please sign at the bottom and return this form to us.

Confirmation

We'll treat your booking as provisional until we've received a deposit and signed terms and conditions. To avoid losing your booking, you need to pay the deposit and return the signed terms and conditions within 7 days of making your reservation. We'll email you when we've received your deposit to let you know your reservation's confirmed.

Deposits & Payments

The deposit is £10 per person for all reservations, and we also require an additional £100.00 deposit to reserve our Pembroke Rooms. When you pay a deposit, you confirm your booking and you'll receive your deposit back by redeeming this against your final bill. If you make any last minute cancellations (see 'Cancellations'), you don't meet the minimum spend we agree, or your guests cause and loss or damage to our property (see 'Loss or Damage'), we may make deduction from your deposit to cover our expenses.

Your bill must be paid before you arrive or before you leave us, by cash, credit/debit card or company cheque. Settling the bill remains the responsibility of the party organiser, and we will seek payment from the party organiser for any charges that are left to pay at the end of your party.

Menus & Pre Ordering

Attached to these terms and conditions is our Christmas party menu. We need a pre-order for this menu, so we can't offer it to you if you want to order on the day. To be able to offer this menu to you, we need your pre-order no later than five working days prior to the date of your reservation, and please inform us of any dietary requirements or allergies on your pre-order, as we may not be able to accommodate them if we don't know about them in advance. The easiest way to submit your pre-order is through our online booking system, and we'll send you link to access this in due course, but if you can't get to a computer, or you don't feel confident about using the online system, please let us know so we can send you a pre-order form.

Cancellations & Changes

If you need to cancel your booking or change the date of your reservation, we need to receive notice in writing at least four weeks before you're due to come to us. Once we've received notice, we'll return your deposit and any advance payments you've made via the same method the payment was received. If you cancel your booking less than four weeks prior to the date of your reservation we won't be able to return your deposit to you, and there may be additional charges incurred as detailed below:

If you need to reduce the number of guests attending, we need to know at least three days prior to your party date. We can still reduce the number of guests less than three days before, but you'll lose £10 of your deposit for each guest no longer attending, and if the number of guests reduces less than 24 hours before you're due to arrive, or you arrive with fewer guests than confirmed, you'll need to pay for the food that each guest not attending was due to have. (based on your pre-order or our estimate)

Loss & Damage

We take no responsibility for loss of, or damage to, personal belongings or vehicles on our premises. Should damage to the property of The Georgian Townhouse take place by a member of your party, it will be to the discretion of the manager as to whether such damage will be charged for. In the instance of a charge being incurred, the organiser shall be liable for this cost.
