The Small Print - Terms & Conditions

Thank you for booking your New Year's Eve party at The Georgian Townhouse, we hope you'll have a great time with us! We want your celebration to go as smoothly as possible, so we've set out some ground rules, which we ask you to read. When you've read these terms and conditions, please sign at the bottom and return this form to us.

Confirmation

We'll treat your booking as provisional until we've received full payment and signed terms and conditions. To avoid losing your booking, you need to purchase your ticket and return the signed terms and conditions within 7 days of making your reservation. We'll email you when we've received your payment to let you know your reservation's confirmed.

Payments

Your tickets must be purchased before you arrive and any additional food and beverage ordered on the night must be settled before you leave us, by cash or credit/debit card. Settling the bill remains the responsibility of the party organiser, and we will seek payment from the party organiser for any charges that are left to pay at the end of your party. We will be taking settlement of any charges from the dining element of the evening prior to commencement of the latter part of the celebrations.

Cancellations & Changes

If you need to cancel your booking or change the date of your reservation, we need to receive notice in writing at least four weeks before you're due to come to us. Once we've received notice, we'll return your deposit and any advance payments you've made via the same method the payment was received. If you cancel your booking or change the date less than four weeks prior to the date of your reservation we won't be able to return your deposit to you, and there may be additional charges incurred as detailed below:

If you cancel or change between two and four weeks before your booking, we'll just retain your deposit. If you cancel your booking entirely between one and two weeks prior to your reservation we'll keep your deposit and you'll also need to pay 50% of the estimated food and drinks bill and, if you cancel less than one week before, you'll need to pay the whole estimated food and drinks bill.

If you need to reduce the number of guests attending, we need to know at least three days prior to your party date. We can still reduce the number of guests less than three days before, but you'll lose £10 of your deposit for each guest no longer attending, and if the number of guests reduces less than 24 hours before you're due to arrive, or you arrive with fewer guests than confirmed, you'll need to pay for the food and drink that each guest not attending was due to have. (based on your pre-order or our estimate)

Menus & Requirements

Attached to these terms and conditions is our New Year's Eve menu. Please note this is the only menu being served on the evening. Please inform us of any dietary requirements or allergies prior to arrival wherever possible.

Loss & Damage

We take no responsibility for loss of, or damage to, personal belongings or vehicles on our premises. If any guest in your party causes theft or damage to our property, we may retrieve the cost of repair or replacement from your deposit, or, if the cost is more than deposit you've paid, we'll ask for payment to cover it. We reserve the right to seek an independent assessment to decide the cost of any repairs or replacements.
